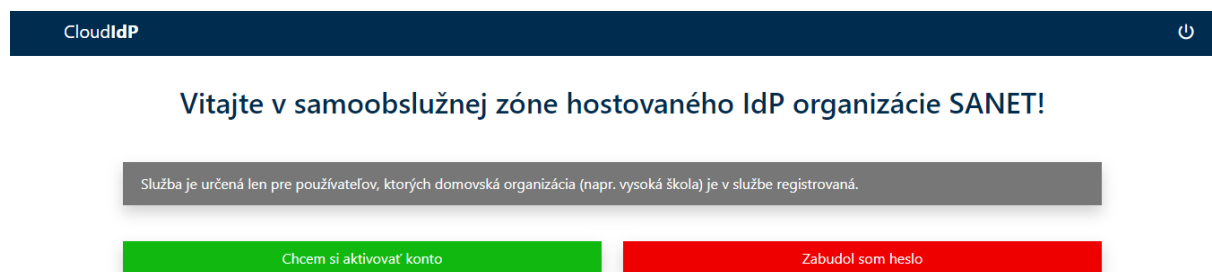


## Egyetemi SAFE ID fiók létrehozása és aktiválása:

Azoknak a hallgatóknak, akik Erasmus mobilitáson fognak részt venni, az online ügyintézés végett aktiválniuk kell az egyetemi SafeID fiókjukat. (Ezt elég egyszer megtenni, az aktivált fiók érvényes marad az adott hallgatók jövőbeni mobilitásai során is.)

A zölddel kiemelt **Chcem si aktivovat konto** gomb megnyomása után a hallgatók megadják az egyetemi mail címüket és megadnak egy jelszót a SafeID fiókhoz. Ezáltal aktiválódik a fiók. Abban az esetben, ha nem létező e-mail cím problémát jelez a rendszer kérem jelezzék felém és segítek Önöknek!
